4. MAP Process

Brian gave an introduction to the MAP discussion. The MAP Report titled "Stage 3: The Story" generated over the summer and the "As heard" report generated at the planning conference have been distributed. St Mark's had the largest representation at the planning conference. The next step in the process is for the discernment team to be struck. Terms of reference for the discernment team were distributed. The goal is to present preferred options for presentation at vestry in February. The Rev. Ross Hammond of the Parish Growth and Renewal Committee (PGRC) will facilitate the process. The report of the discernment team is due in December.

All individuals present were invited to speak on issues close to their heart regarding the MAP process. During discussion, concerns were raised about accuracy and scope of data and the designated time frame for the process. After the meeting had continued almost 2 hours, it was determined that the issues could not be resolved at this meeting and the general feeling in the room was assessed. The results were:

- **a.** Nobody in the room is willing to make a final decision in February.
- **b.** When asked the question: Who would be prepared to move forward? 11 answered yes, 9 answered no.

The consensus was that the leadership team needs to come back to us again taking into account a longer time frame. It was also felt that more information and reviewing the accuracy of the information was needed. More discussion needs to occur within St Mark's.

Brian expressed thanks to the participants for their sharing at beginning of evening and heartfelt participation over the evening and urged everyone to continue to stay engaged with the process.

The open portion of the meeting closed at 9:30 with Doxology.
