7. Rector's Report

- **a.** Draft minutes from the Vestry meeting held on February 20, 2011 are included for your reference.
- **b.** We were invited to send two people in addition to myself to a preliminary meeting between the Deanery of Ottawa West and the Parish Growth and Renewal Committee of the Diocese which took place on March 2, 2011. In consultation with the wardens, Georgia Roberts and Judy Darling were asked to attend on our behalf. The notes from that meeting are included, and another meeting is planned for May of this year.
- **c.** Great Chapter has been called for the Deanery of Ottawa West to take place on Thursday, May 19, 2011 7:00 PM at St Michael and All Angels. The agenda will include a presentation

from the Leadership Team of the Diocesan Financial Campaign (2012).

8. Warden's Report

Roof and Solar Panels

- **a.** Financial Affairs meets March 23. If there are changes recommended by Parish Council, we can submit them to Financial Affairs.
- **b.** An approximate timeline for the project is as follows:
 - January 6 Application to Ontario Power Authority for a 10 kiloWatt solar installation
 - February 28 Last day for acceptance of bids for the roof and solar installation
 - March 1 Review of the adequacy of the bids by the Corporation
 - March 7 Connect submission to Hydro Ottawa for the proposed installation
 - March 16 Choosing of winning bids by Parish Council
 - March 23 Approval of roof and solar bids by Diocesan Financial Committee

About mid-April –(Guess) Conditional contract offer from Ontario Power Authority, subject to the acceptance of agreement to connect the proposed installation by Hydro Ottawa

About mid May to mid June – (Guess) Start of roof and solar installation

If there is no contract offer from OPA or agreement to connect by Hydro Ottawa, then the roof will proceed without the solar installation.

c. A copy of the submission to Financial Affairs was included. It suggested Lucas NRG for the solar panels and Lucas Roofing for the roof. These are both the same person which will make life much easier. He has also agreed to install the new roof cross.

9. Treasurer's Report

a. There was nothing startling this month. We are about where we expect to be. Our current year's expenses have exceeded our income by about \$7,000. Our collections income is down about \$800, which occurred during February.

10. Property Report

- **a.** On Sunday March 13 Lorne discovered that 7 of the 6 foot folding tables from the basement were missing. No one seemed to know who had them. No note was left, nor was there any notification sent to the office. On March 16, 5 of the 7 had been returned leaving two missing. Hopefully the last two will return as well. It is not right to take them without permission.
- **b.** The Property Team put plastic on the lower windows of the Conference Room to stop the large build-up of ice.
- **c.** A glass globe in the Hall was cracked somehow. After a two week search, we have found a replacement. We also ordered two spares.
- **d.** Penny Miller reported a leak from the roof just in front of the rug in the Sacristy. Hopefully, it is just the accumulated snow melting and backing up the roof.shingles.
- e. We are getting complaints from our neighbor to the south about leaving our garbage cans in

her driveway. We need to establish a better method of handling where we put the garbage in the winter time when the snow blocks our usual place. Lorne has suggested that we ask the snow removal contractor to clear the area around the hydro pole and a clear a path to the kitchen door. Parish council wondered if the city workers were leaving them in the driveway.
