**1. Call to Order** at 7:30 by Brian Kauk.

**2. Opening Reflections:** by Jenny Morphew. The term Lent used to mean the spring season. A prayer was read which was adapted from a prayer by St Ephraim of Syria.

#### 4. Election of Parish Council Chair

## 5. Approval of minutes.

- **a.** Correction of the spelling of Daron in paragraph 2.
- **b.** Treasurer's Report (clarification)

Two documents were distributed by the Treasurer - (i) the Balance Sheet as of January 31, 2012 and (ii) a comparison of January actual income and expenditure items to the January amounts budgeted (using January budget amounts based on the annual budget to be presented to Vestry on February 19). The Treasurer reported the following:

- Last year's deficit (\$5,547.76) is shown on the Balance Sheet as an internal loan.
- In the 2012 budget to be presented at Vestry on February 19, the deficit is much higher than what was seen in the draft budget at the last meeting (\$15,331 versus \$6,027). This is mainly due to the numbers from the diocese for salaries being about \$8,000 higher than expected. This higher amount is because of lower income than what we were expecting from the Rectory Trust (approximately \$2500 lower) and increased hours for the parish administrator.
- We ended January 2012 with expenditures exceeding income by approximately \$2,000 (which was what was anticipated in the monthly budget).

### 6. Business arising from previous minutes

**a.** Proposals for use of 2011 memorial funds were not received. The congregation will be invited to make proposals. We will look at this again next month.

#### 7. Rector's Report

- **a.** From a meeting held on February 15, 2012 with the Lay Assistants at Communion (LACs), I would like to submit the attached proposal for lay leadership of Services of the Word. In it we propose training will take place at the 10am services once per month.
- **b.** Following from this:
  - I intend to invite Nash Smith the lead worship at 10am on Sunday March 25.
  - I would like to invite this Council to nominate anyone you see as appropriate for the role of administering the chalice. This is separate from leading the intercessions, the second reading and vesting as a part of the procession.
  - I would like to encourage anyone in this parish interested in reading scripture or leading intercessions to speak with me at any time. Training is available.
- **c.** The Diocese is promoting a Congregation Development Day to take place on Saturday, April 28, 2012. Both I and the Wardens would like to encourage a strong showing at this event. As a part of the S.P.A.C.E program, St Mark's will cover half the registration fee for all who register on or before Friday, March 30, 2012 (the Early Bird Fee deadline). - **d.** St Mark's has received a Thank You from The Well/La Source, which will be posted in the link. As well, St Mark's Mothers Union branch received a Thank You from the Anglican Mission Service Committee which supports the work of Mary Sherwood in Madagascar.

### 8. Warden's Report

- **a.** We have received the Microfit contract. The contract runs until February 2, 2032 and pays 80.2 cents per kilowatt hour.
- **b.** The revised GIFT target has been received from GIFT Campaign Committee.
- **c.** Carleton Memorial Daycamp has asked to use the hall over the summer. This will be discussed later under Other Business.
- **d.** We will be joining the diocesan Easter ad campaign.

#### 9. Treasurer's Report

- **a.** Our deficit to the end of February is about \$6,000. This is about where we expected to be. It is very difficult to tell exactly how we are doing in the first few months of the year.
- **b.** The large expense for the bazaar is note cards which were donated by John Topelko. We pay for them and the cheque is returned to us to allow for a tax receipt. The cheque was written in February and will be returned to us in March.
- **c.** Our offerings are down about \$2,000 to date. It is hard at this point to say whether it was the weather or a continuing trend.

### 10. Property

- **a.** The office roof has been completed. We still have a couple of small leaks in the side roof of the Church which Lucas will come back and repair.
- **b.** Les spent a busy morning taking gravel and snow off the Link flower bed, for which Connie is very grateful. The Navy Lady roses looks like they came out OK.
- **c.** We have a leak in both washrooms that we have not traced yet. It is probably up overhead in the attic and running down the space between the two washrooms (There are two concrete block walls with a space in between for the pipes. A terrible arrangement if we have to do repairs.) Lorne with help will look at it this week. It cannot go on.
- **d.** The outside sump pump has failed, so the inside one is carrying the load for the moment. We did have a flood because Lorne did not plug the inside pump in after the electrical work. Lorne will wait until Paul Greer comes back to change the outside pump.
