Rector's Notes February 2022

Bible Study

I'm grateful for the continued support for Bible Study. The first in a 2-part series has come to an end. In the first part, we examined 1 Corinthians. The second part commences March 9th and will focus on the lectionary gospel for Lent, Luke.

BHM

PROBUS

A few parishioners joined me for the PROBUS lecture February 2nd. Your presence was greatly appreciated and the members of PROBUS have sent their many thanks.

Psychotherapy

There are people of our community of faith who are in need of professional help psychologically. Currently, Cornerstone House is assisting us in this regard. We are grateful for the support that this body is providing us.

SPMC

The parish requested an extension for the SPMC but we were unsuccessful in obtaining that extension. This would've given us more time to properly organize our responses. One suggestion was to bring in a facilitator. This proposal I don't support because it could've been time consuming, costly and open the door to endless debates. Thinking about the proposal gave me PTSD because of the fallout from the M.A.P. program. The decision I'm making maybe unpopular but at times leaders are called to make them. My main concern is to do my best pastorally to keep the body of Christ in unity.

Therefore, Parts 1, 2 & 3 are due on 28th February and Parts 4 & 5 are due by 10th March.

I am encouraging all participants to converse with other team members. Let us truly show team spirit with the diocese and have this process completed to meet their deadline.

Liturgy

It has come to my attention that some parishioners wish to make decisions above that of the Incumbent as it relates to the liturgy. Ultimately, decisions related to the liturgy are those of the priest. Currently, I have a de facto worship team made up of myself, Joy Bowerman and Ariane Dind. At the same time, please be reminded that the canons of the diocese have vested ultimate decisions of the liturgy in the Incumbent

Discrimination

I spoke with Bishop Shane about a few troubling issues of racism. These were beyond hearsay because I actually have the emails in my possession. He has advised that if the issues are unresolved that he would be open to convening a tribunal to look into harassment on the job. I'm praying that it doesn't come to this but I'm unwilling to sit by idly and take no action.

<u>Further to the report:</u> There are 2 weddings booked for this year but dates are not determined as yet.

During the Easter season a baptism has been planned.

The 8am communion service is slated to start again in April.

Bible study will resume during Lent and will cover the Book of Luke.

Beth Muma, a new member of the parish, has joined us as a lay assistant.

John MacFarlane: the situation is calming down. The diocese will assist us in response to any other problems that may arise. It will not be brought back to Council unless needed.

The new Deputy Rector's Warden is Laurie Slaughter. Suzanne Bisson has offered to stay on as Rector's Warden for 2 extra years and Laurie will in essence shadow her in order to "learn the ropes".

At this point in the meeting Joy Bowerman joined us. She gave a historical financial overview of the finances and budget planning at St. Marks. This overview had originally been presented to the Financial Advisory Committee while it reviewed the draft budget for 2022.

Treasurer's Report

Some comments for Parish Council about January 2022 Financials

After just one month into the year, there is not too much to be said about our financial numbers. However, here are a few comments.

Balance Sheet for 31 January 2022

There has been no change in any of our reserve accounts since December 31, 2021

Income in January

Collection income for January 2022 (\$12,021) was good, and \$1,757 higher than January 2021.

We had both higher investment income and solar income in January 2022 than we had in January 2021. Good news, since we are predicting both assets to produce more in 2022 than in 2021.

A new organization meeting at St Mark's - AA - has made its first donation.

Total General Income in January 2022 (\$13,382.88) was \$2,439 higher than in January 2021.

Total Directed Income in January was \$126, coming from flower donations and a donation for Forward Day by Day.

Expenditures in January

Memberships were paid for the Anglican Foundation and the Council on Aging of Ottawa.

The expenditure of \$1832.82 in Repair and Upgrade was for the down payment on the basement repairs to prevent flooding.

Total expenditures in January 2022 (\$19,628.70) were \$1,721.76 higher than in January 2021

Bottom Line

In January 2022, our expenditures exceeded income by \$6,119.82

Budget 2022

There has been a small change in the budget figures due to the fact that a few rentals are coming in. There are other renters who also want to return and so the new figure in the budget might be slightly underestimated. This may also be true of the collections numbers since we could open back up again sometime this year. The diocesan numbers are quite large but cannot be negotiated and fixed costs such as hydro, gas and water have to paid.

Property Report

Property Report February 2022

The work is underway in the basement to fix the water leakage problem. It should be completed on Wednesday February 16, 2022 so the basement will be available for rentals on Thursday.

John Hancock and I looked at the problem sink in the basement. We are going to replace the sink and the vanity. John is going to contact a plumber he knows to come and first advise what we should buy to replace the existing sink and vanity.

Property Report Solar Panels

In March and April I called Execon Roofing and Solar asking for help to get St. Mark's solar array repaired under warranty.

This company contacted Enphase, who had supplied the solar array components in 2011.

When the replacement parts arrived and a crew was available, the work began.

Full power was restored in June.

Graph 1 indicates the change of output from June 8 to June 9, an increase from about 38 kilowatt hours to about 59kWh.


The more recent example of power output, figure 2, for January 30 has a peak power of 10 kilowatts for each 15 minute interval.

So, $10 \text{ kW} \times 1/4 \text{ hour} = 2.5 \text{ kWh per interval or } 10 \text{ kWh per hour}$. The sum of heights of all the bars gives 57.2 kWh, January 30.

The line of figure 2 represents the bar heights for January 29, where a <u>full</u> day of sun resulted in 64.3 kWh output for Hydro Ottawa.

Power production for the month of January, 2022 was 983.9 kWh.

Lenten Outreach

PROPOSED LENTEN PROJECTS 2022 FOR DISCUSSION

At our Parish Council meeting tomorrow, we should discuss and approve our 2022 Lenten projects. Here are two suggestions made by PC members, however if you have any other recommendations, please bring them forward tomorrow.

Diocesan community ministries - Today for Tomorrow

Over the years, St. Mark's has previously made many of the diocesan community ministries as our Lenten projects. We have a choice of donating to Today for Tomorrow, so that money goes to all of the ministries or we can direct our donation to one of the ministries. For example, this year, it is suggested that a Lenten project could be The Well.

1. The Well/La Source

The Well is one of five Community Ministries operated by the Anglican Diocese of Ottawa. The Well is guided by the core values of the Community Ministries, which above all else, in a spirit of mutuality, respect the dignity of every human being in the desire to address social injustice. Many of the women that The Well helps experience challenges and injustices in their lives, including homelessness, poverty, ill health, mental health problems and addictions. The Well takes a holistic approach and provides programs to ensure that all women have access to effective tools, resources and support services required to build the life they choose for themselves.

2. Lytton Fire Response

The Territory of the People, the Nlaka'pamux Nation, and the Village of Lytton were faced with the disastrous fire in Lytton in the summer of 2021 that destroyed most of the town including St. Paul's Anglican Church, a 108-year-old church on Gitwangak First Nation land near New Hazelton.

In summer 2021 PWRDF donated a solidarity grant of \$5000 to the Territory of the People. The Territory also raised funds directly to help clergy provide cash for emergency needs of those who were made homeless or were displaced by the fire. It is anticipated that donations now will help support future rebuilding.

Donations can be made via Canada Helps, PWRDF. As well, Janis has written to All My Relations regarding a means of donations and more information. We should have a response to share at our PC meeting tomorrow Tuesday at 2 pm.

<u>Further to the proposal:</u> All My Relations had no information regarding Lytton for Janis Perkin and suggested contacting PWRDF. Cynthia Greer has contacted the priest of the parish church in Lytton and is waiting for more info.
