3. Business arising from previous meeting (s)

Updating of the "What we Do" section of the St. Mark's website continues to be a work in progress. Mike Duval has been approved to buy four units of solar lights for the outdoor sign from a Canadian company, BigM, for \$610.20, including taxes and free shipping. While slightly over budget, it was agreed by all that the quality and warranty merited the choice.

4. Regular Reports

a) Interim Priest's Report

Father David extended a warm welcome to the new Parish Council members, Gillian Martin, Mayowa Ojo and Sophia Chiboka. February was a busy month with Vestry, Black History Month and Bible Studies added to our usual activities. Approximately 30 parishioners gathered in the parish hall for a quick lunch before our Vestry meeting which wrapped up in just over an hour.

Black History Month was a success due to the effort put forward by the BHM committee, the 2 speakers and everyone who contributed to the food and hospitality. After Black History Month was over, the children from St. Rita's School were invited to observe the display of their pictures. About

40 or 50 children were treated to a brief history of St Mark's. Their artistic efforts are greatly appreciated every year.

b) Wardens' Report

Black History Month

The BHM wrapped up on Sunday March 2 with Guest Speaker Yolande Parsons and followed with an Augmented Coffee hour. Even though we had fewer Guest Speakers this year, all other events were organized as usual, with a rather low-key feasting on March 2. The Fashion show with St Thomas was well-attended and bigger than last year with many more participants. The Panel discussion was also vibrant with good discussions and conversations about the contributions of Black People in Peace all around the world. Panelists also shared their experiences in Canada in general and in relation to peace.

Many thanks to teachers and students of St Rita for supporting this year's celebrations with artwork. The committee is chaired by Mayowa Ojo with membership of Janis Perkin, Sophia Chiboka, Joseph Amuah, Joan Hounsell, and Marion Namukwaya.

Extra special thanks to our team of volunteers at the extended coffee hour who helped set things up and did all the amazing work to make the mini feast so successful. And many thanks to all those who prepared amazing bites, some of which were gone in a flash!

Fire Extinguishers

Janis Perkin has been working with Anderson Fire Protection to tune-up our Fire Extinguishers and replace batteries. Daniel from Anderson Fire Protection was at St. Mark's on February 24th to collect those extinguishers that needed re-powdering and put in loaners until the job is completed. The battery for the emergency light was also replaced. It is estimated that it will take 2 weeks. There was a delay due to vacations and illness at Anderson Fire Protection.

We need to replace John Hancock and Suzanne Bisson as signing authorities for our TD Bank account. Janis is working with the bank to replace them with Gillian Martin and Mike Duval.

All the proceeds from last year's stamp auction were used to support a new program called the Oxfam Emergency Response fund.

Joy will continue to pass on the milk bags that are used for making braided rugs. I hope to get out to Greely and see how they are made. I hear it is quite an interesting process

Today Joan Hounsell helped me to deliver our bins to Debra Dynes Family House. For those of you who wish to donate this week, they are especially in need of pasta, tuna, and tinned milk.
